Review and inspection of the construction process is required to assure Code compliance. The following are the minimum inspection approval requirements for new construction:

1. Footing – After excavation and any forming PRIOR to concrete pour.
2. Foundation – After construction, prior to backfill, complete with foundation drains, damp proofing and embedded anchor bolts and BEFORE any framing, including sill plate.
3. Framing – After construction, PRIOR to insulation and interior wall covering. Plumbing, electrical, etc. shall be “roughed in.”
4. Insulation and Wallboard – Prior to wallboard installation, R-Values in exterior walls, ceilings and floors if required must be verified. Wallboard fasteners inspected prior to finish.
5. Final – After structural completion, with all fixtures and devices complete and functional.

Over \$ 10,000.01 valuation, the permit fee shall be \$200.00 plus \$7.00 for each additional thousand dollar valuation of fraction there of.

Cost of work will be based on the contract for the work of the Code Officials estimate based on the R.S. Means Co. Inc. " Construction Data Book" (most recent edition)

Any Individual or Contractor who shall begin work prior to securing a permit shall pay a fee equal to two times the fee that would have been charged had they received the permit prior to commencement of work.

$\$160.00 \times 25\% = \$40.00 + \$160.00 = \$200.00 + \$4.50$ State Fee Total due :
 $\$204.50$, deck exceeds 300 sq. ft. you must add 1 % of total cost of job, plus
 $\$204.50$, **Example** : 500 Square foot deck would be $\$204.50 + 1\%$ of the **Total Cost of Construction, Deck Cost contracted** at 500 sq. ft., $\$3,000.00$, add 1% of total to the $\$204.00$, 1% of $\$3,000.00 = \$30.00 + \$204.00 =$ Total due: $\$234.50$
